



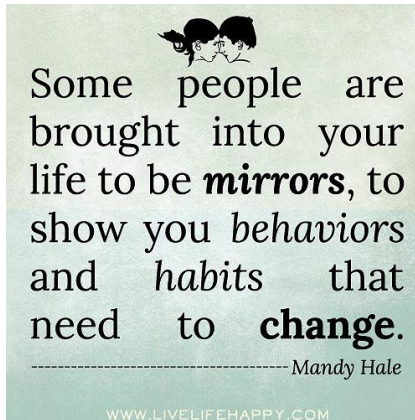
DAIP gives the offender the opportunity to address their domestic violence issues.

A Proactive &
Voluntary Diversion Program

Admission to the Program

The Domestic Abuse Intervention Program (DAIP) is designed to begin promptly after a person is arrested for a domestic abuse related crime.

It is a voluntary program.

Individuals interested are to contact the Justice Programs Coordinator within 5 days of the initial appearance to schedule an intake interview.

The participant will receive information on community resources available for programming.

Eligibility

1. Individuals who are able and available to complete program requirements.
2. Individuals who are open to changing values that drive abusive behavior.
3. Individuals charged with a domestic abuse related crime, including but not limited to disorderly conduct, assault & battery, victim intimidation, etc.

Participant's Responsibility

- Follow all conditions of bond, if applicable
- Remain alcohol and drug free throughout the program.
- Cooperate with random alcohol or drug tests.
- Sign consent forms for the release of information to/from other agencies
- Pay a program fee of \$100.00

Incentives to Participate

- Increase personal growth
- Change unwanted behaviors
- Gain a support system
- Reduction in fines
- Avoid traditional punitive sanctions(i.e. prison or jail) depending on the severity of the crime
