Washburn County

Washburn County is located in the northwestern part of the State of Wisconsin. Created by an act of the Legislature in 1883 out of territory taken from Burnett County, it was one of the last counties to be created in Wisconsin, and was named in honor of Cadwallader C. Washburn, who was Governor of Wisconsin from 1872 to 1874, and a Union General in the Civil War.

Washburn County consists of 21 towns, two villages and two cities, with a population of approximately 17,403 people. There are six school districts in the County: Shell Lake, Spooner, Northwood, Rice Lake, Hayward and Birchwood Schools. The County Seat is located in the City of Shell Lake.

In the early days, the northwest territory of Wisconsin, was the first home of the Sioux Indians and later the Chippewa Indians. Beginning in 1837, the Chippewa Indians made a series of treaties with the United States Government by which all of northwestern Wisconsin was eventually ceded to the United States, with the exception of certain "Indian Reservations," which were set aside for the home of the Chippewa Indians.

In the 1800's, Washburn County, had a heavy growth of White pine and Norway pine as well as many species of hardwood and other timber. Logging started in the 1860's along the rivers and creeks, but did not get into full swing until the 1880's. The Namekagon and Totogatic Rivers, which flow through the north, and the Clam and Yellow Rivers, which wind through the central and southern parts of the County, were used as logging waterways because of their connection to bigger rivers such as the St. Croix and the Mississippi. The logs were floated down these streams to be milled into lumber at Stillwater on the St. Croix River and at some points further south along the Mississippi.

Today logging and timber products are still marketed from the County. Potatoes from West Farms in Sarona, cranberries from various owned marshes, and dairy and beef cattle farms are the major industries. There are also furniture and cabinetry manufacturers, as well as a veneer plant located in Birchwood. Spooner has several metal fabricating and other manufacturing businesses; and Minong is the home of Jack Link's Snack Foods, shipping snack products worldwide. The tourist trade is increasing year by year and furnishes substantial revenues to our citizens who cater to the trade.

Washburn County is a beautiful place to live and vacation. We offer opportunities for four-season recreation including: camping, canoeing, hunting and fishing, and miles of trails for ATV riding and snowmobiling, horseback riding, cross country skiing, and hiking. The outdoor enthusiast has access to 148,000 acres of public forestland. With over 900 lakes, several rivers, and many woodland streams; the angler can pursue abundant populations of: Northern Pike, Largemouth and Smallmouth Bass, Walleye, Muskie, Panfish, Catfish and Trout. The Namekagon River, part of the National Park Service Wild River system, noted for its natural beauty, is enjoyed by our summer guests and locals alike in canoes, kayaks, and tubes.

There are many fun festivals and activities in the county including: Stone Lake Cranberry Fest, Birchwood Bluegill Festival, Minong Summer Days, Town and Country Days in Shell Lake, and the Spooner Heart of the North Rodeo, which brings in cowboys and visitors from many states. The Northwest Heritage Passage is a tour of historic sites as well as galleries, craft shops and other points of interest. Museums include: Museum of Woodcarving, world's largest collection of life-sized woodcarvings by one person, located in Shell Lake; Railroad Museum housed in the 1902 Chicago & Northwestern depot in Spooner; and other local historical museums.

Washburn County is also home to Northwest District DNR, District 8 of the Wisconsin State Patrol, and District Offices for Wisconsin Indianhead Technical College. The Tommy Thompson Fish Hatcheries in Spooner, is the largest walleye and musky hatchery in the U.S. Washburn County is honored to have the Northern Wisconsin Veterans Memorial Cemetery located in our county. The internationally known Indianhead Arts Center in Shell Lake has classes on music, theater, visual arts and textile arts each summer and attracts top students to the workshops.
