## **CUTTING INSTRUCTIONS:**

**AREA A**[N. Hdwd]: Harvest all orange marked trees between purple marked gaps within designated boundaries. Within purple marked gaps (~120 ft. across) harvest all merchantable trees except "ringed" marked reserve trees. Site maintenance required within the gaps: sever all un-merchantable stems >1". (96 acres)

**ÀREA B**[N. Hdwd]: Harvest all orange marked trees within in designated boundaries. No hot saw allowed to limit impact on red oak saplings. (27 acres)

**AREA C**[N. Hdwd]: Harvest all aspen and hardwood species within the designated boundaries. All unmerchantable stems 1" dbh and larger shall be severed at sale completion. Reserve all conifers and yellow birch. (7 acres)

## Access, roads & landings:

- Reconstruction of existing forest trails will be needed.
- Landings shall be located where indicated on the prospectus map unless prior approval is obtained from the County Forest Administrator.

Recreation:

- Recreation trail surface will have to be restored to at least existing condition and any damaged signs/posts will have to be replaced by the contractor.
- Recreation trail shall be maintained snow covered during winter months and free of debris at all times.

## <u>BMP's:</u>

No slash will be left in any non-forested wetlands. Do not operate wheeled or tracked equipment within 15 feet of wetlands except during frozen conditions.

<u>Slash:</u>

Contractor is encouraged to leave large tops within purple marked gaps to help discourage deer browsing hardwood seedlings.

Seasonal Restrictions:

> Area B and C: Harvest operations restricted to frozen ground conditions.

## All additional restrictions listed on the prospectus sheet apply unless otherwise specified.

# MANAGEMENT CONSIDERATIONS

**AREA A:** are northern hardwood stands scheduled for a group selection harvest with canopy gaps and single tree selection in-between. Level to rolling topography on silt loam and sandy loam soils with a dry summer logging chance.

**AREA B:** are northern hardwood stands scheduled for a single tree selection. Level to rolling topography on silt loam soils with frozen ground conditions required.

**AREA C:** is a northern hardwood stand scheduled for an uneven age management to even age management clear cut harvest. Level topography with frozen ground conditions required. <u>ACRES</u> 130
