DESCRIPTION: S1/2NE, NWNE, SESW, SE Sec. 1, NWNW, NENW, NWNE SEC 12, T41N-R12W (Brooklyn N), SWSW Sec 6 T41N R11W (Gull Lake)

VOLUME, SPECIES & PRICE:

3,300 Tons Oak (~ 1,200 Cd. <5% white oak)

1,000 Tons Mixed Hardwood (~440Cd, 2.28 ton/cd, 30% white ash, 27% red maple, 24% sugar maple, 14% basswood, 5% white birch)

195 MBF Red & White Oak (<5% white oak)

35 MBF Mixed Hardwood (49% basswood, 35% white ash, 9% red maple, 6% white birch, 1% sugar maple)

TOTAL MINIMUM BID: \$ 53,520.00

NOTE: 3 Year Contract, No harvesting activity permitted from April 1 through July 15. Oak wilt restriction.

CUTTING INSTRUCTIONS:

AREA A [Red Oak]: Harvest all orange marked trees between purple marked gaps within the designated boundaries. Within the purple marked gaps (100-120' canopy gaps) harvest all merchantable trees. Site maintenance required within the gaps: sever all un-merchantable stems > 1". (145 acres)

Access, roads & landings:

- No new roads will be permitted. Reconstruction of existing forest roads will be needed for hauling.
- Landings shall be located where indicated on the prospectus map unless prior approval is obtained from the County Forest Administrator.

Seasonal restrictions:

- Dry summer logging chance, after July 15th oak wilt restriction. Harvesting operations allowed only when soils are dry enough to support equipment.

BMP's:

- No slash will be left in any non-forested wetlands, ephemeral ponds, open water or designated stream channels. Do not operate wheeled or tracked equipment within 15 feet of wetlands except during frozen conditions.

Recreation:

- Recreation trail surface will have to be restored to at least existing condition and any damaged signs/posts will have to be replaced by the contractor.
- Recreation trail shall be maintained snow covered during winter months and free of debris at all times.
- 15 mph caution ahead signs will need to be posted during harvesting operations.

Harvesting modifications:

- Contractor encouraged to leave large tops on site to help discourage deer browsing hardwood seedlings.

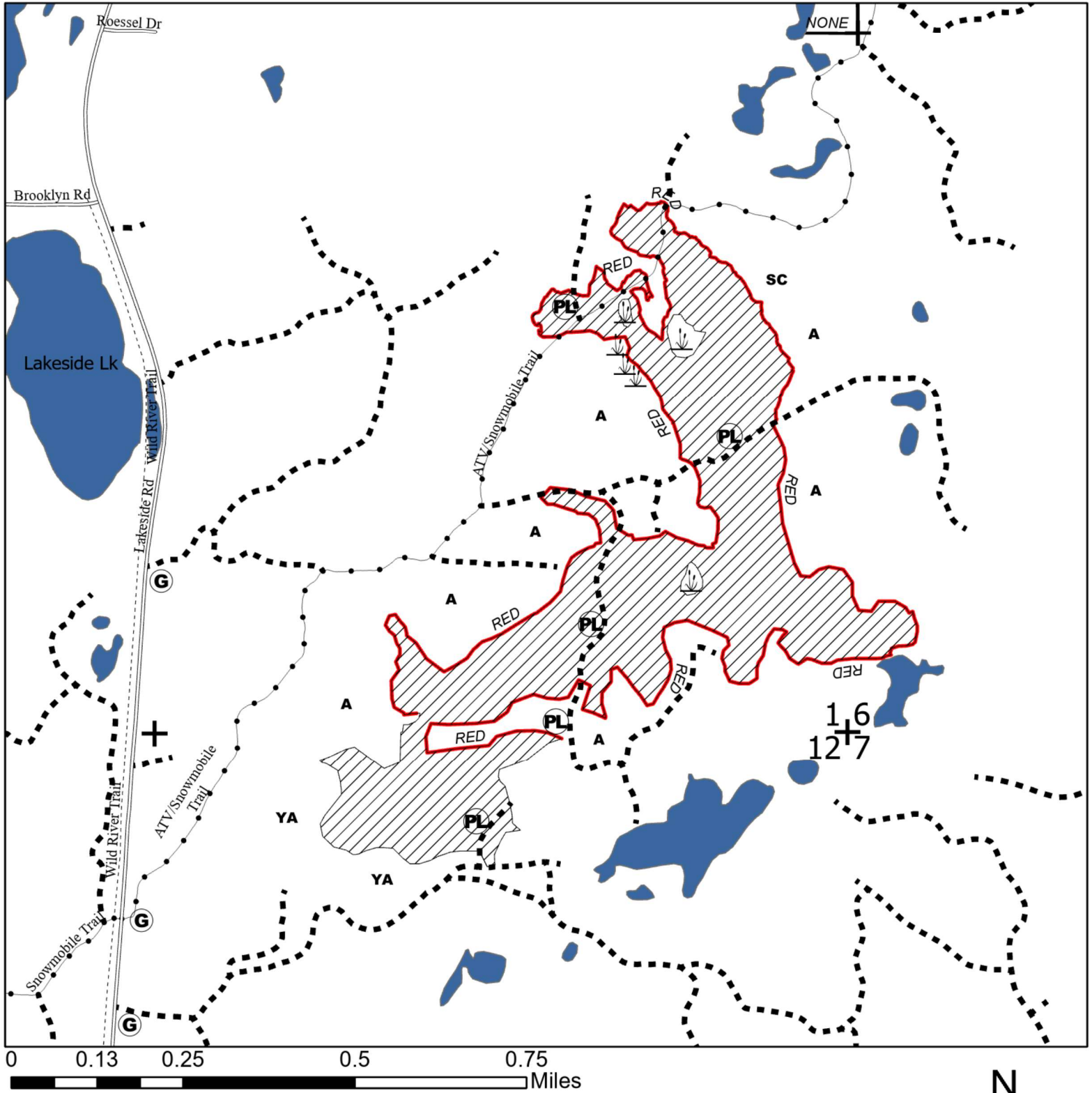
All additional restrictions listed on the prospectus sheet apply unless otherwise specified.

MANAGEMENT CONSIDERATIONS

Area A: is a 92 year old red oak stand scheduled for a gap and thin. The stand is on primarily sandy loam soils with level to moderate topography. Dry summer chance after July 15th Oak Wilt restrictions.
