HOUSING

- Availability of land for residential development and where most advantageous to locate single and multi family housing
- Location of mobile homes
- No minimum lot size

TRANSPORTATION

- Maintenance of local roads

- Speed limit posting
- Roads being open to snowmobile and ATV use
- Developer requirements to bring up to set standards before town can take over
- No current airstrip. Where would be an appropriate location if one was to develop
- No or very limited public transit service

UTILITY AND COMMUNITY FACILITIES

- Need for improved school facilities
- Limited availability of day car service
- Potential for high power voltage lines
- Limited recreational facilities (boat landing, golf course, playgrounds, sawyer creek wildlife area)

- Comm83 and development of lands not able to carry development

AGRICULTURAL, NATURAL & CULTURAL RESOURCES
