- 1. Call Meeting to Order at 9:00 a.m. by Chair Mackie.
- 2. Moment of Silent Meditation and Pledge of Allegiance was led by Supv. D. Masterjohn.
- 3. Notice of Meeting was read by County Clerk Olson.
- **4.** Roll Call was done by County Clerk Olson. Board members present: (20), vacant: (1) District 19; Youth: (2) Olson, Robotka.
- 5. Approval of October 15, 2019 County Board Proceedings by J. Dohm, 2nd by D. Masterjohn, MC.
- **6.** Concerned Citizens None at this time.
- 7. Youth Government Day Introduction Students from Spooner, Shell Lake, Birchwood, Northwood schools introduced themselves. Board members spoke about their experiences with getting involved in government service including Stephen Smith, Romaine Quinn, Tim Kessler, Linda Featherly, Tom Mackie. Chair Mackie reported on the building project and having youth representatives on the board. Discussed differences between town and county governance.
- 8. Resolution 63-19 for 2019 Tax Levy and 2020 Budget The County set the 2020 levy at \$10,923,291 with a County mill rate of 4.223 per \$1,000 of equalized valuation. Motion to approve by D. The total budget is about \$45 million in 2019 and about \$43 million for 2020. The county mill rate was .4386 for last year. D. Haessig reviewed this year's projects including a new Forestry building in Spooner, a new Shell Lake Senior Center, and county maintenance shop. Chair Mackie explained that all taxing entities have a mill rate WITC, State, Local, County. Roll Vote: Yes (20), Youth: Yes (2); MC.

RESOLUTION OPPOSING ANY LEGISLATION THAT WOULD INFRINGE ON THE SECOND AMENDMENT

WHEREAS, the right of the people to keep and Bear Arms is guaranteed as an Individual Right under the Second Amendment to the United States Constitution, and under the Constitution of the State of Wisconsin, Article 1, Section 25 – "The people have the right to keep and bear arms for security, defense, hunting, recreation or any lawful purpose", and;

WHEREAS, the Right of the people to keep and Bear Arms for defense of Life, Liberty, and property is regarded as an inalienable Right by the people of Washburn County, Wisconsin, and;

WHEREAS, the people of Washburn County, Wisconsin derive economic benefit from all safe forms of firearms recreation, hunting, and shooting conducted within Washburn County using all types of firearms allowable under the United States Constitution and the Constitution of the State of Wisconsin, and;

WHEREAS, Washburn County Board, being elected to represent the people of Washburn County and being duly sworn by their Oath of Office to uphold the United States Constitution and the Constitution of the State of Wisconsin, and;

WHEREAS, the Wisconsin House of Representatives and the Wisconsin Senate, being elected by the people of the state of Wisconsin and being duly sworn by their Oath of Office to uphold the United States Constitution and the Constitution of the State of Wisconsin, and;

WHEREAS, any legislation considered by the Wisconsin State Legislature that would infringe the Right to Keep and Bear Arms and would ban the possession and use of any firearms, magazines, and/or ammunition now employed by individual citizens of Washburn for defense of Life, Liberty and property, or would require a firearms owner I.D. card or tax the possession of firearms or ammunition within Washburn County, Wisconsin;

Be it further resolved the people of Washburn County, Wisconsin affirms its support of the Sheriff to exercise sound discretion to not enforce against any citizen an unconstitutional firearm law.

Be it further resolved that the Washburn County Board will not appropriate any funds for any enforcement of unconstitutional laws against the people of Washburn County, Wisconsin.

NOW, THEREFORE, IT BE AND IS HEREBY RESOLVED that the people of Washburn County, Wisconsin, do hereby oppose the enactment of any legislation that would infringe upon the Right of the people to keep and bear arms and consider such laws to be unconstitutional and beyond lawful legislative authority.

5.1 SAFETY PROTECTION

Washburn County believes that safety is very important and provides employees with the personal protective equipment necessary for employees to safely perform their job. In addition, the County shall provide the following benefits for safety shoes and safety glasses:

Safety Shoes

Employees whose positions (for example: highway, forestry, zoning, surveyor, maintenance, and jail*) warrant require foot protection will be reimbursed up to \$150.00 per 12-month period year. Employees may purchase safety shoes from approved vendors; or if purchased elsewhere, and sales tax was incurred on the purchase, up to \$150.00 will be reimbursed, excluding the sales tax, which is not subject to reimbursement.

*Casual status jailers may purchase safety shoes on their first day of employment, but must be employed by the County for 6 months before they become eligible for reimbursement under this policy.

• Safety Glasses

The County shall provide non-prescription safety glasses for those employees who are required to wear safety glasses as PPE. Employees who wear prescription glasses and whose positions require safety glasses will be reimbursed up to \$150 per 12-month period for prescription safety glasses if they are non-reimbursable from another source (i.e. vision insurance). If sales tax was incurred on the purchase of prescription safety glasses, up to \$150 will be reimbursed, excluding the sales tax, which is not subject to reimbursement.

The actual purchase receipt must be submitted in order to receive reimbursement under this policy. All employees reimbursed for safety shoes and/or prescription safety glasses will be required to wear them at all times when such personal protective equipment is warranted. Each department manager will be responsible for monitoring safety apparel specific to the duties of their department and use thereof.
