- C. Resolution 2022-64 to Approve New Position of Part Time Spooner Dining Site Manager Assistant / Cook— Aging/ADRC motion to approve by Supv. D. Wilson, 2nd by Supv. J. Hoy. Supv. S. Smith indicated that these positions still need to be approved at budget time. ADRC Supervisor/Aging Director Linda Hand reviewed the request along with meal statistics. Birchwood, Spooner and Minong are open 5 days/week and Shell Lake is only open 2 days/week currently and the request will allow 5 day/week coverage for Shell Lake. Supv. B. Olsgard spoke in support of the position and it will allow Meals on Wheels and congregate meals to be cooked from the Shell Lake site as well. It was clarified that this 30 hr/wk position will assist the Spooner Site Manager, thereby allowing the Shell Lake Site Manager (who currently assists at Spooner) to come to Shell Lake to provide the 5 days/wk service. This position won't be posted or filled until January 2023, as this is a 2023 budget request. Supv. D. Wilson spoke about utilizing several current LTE slots to help with funding the position; Supv. C. Stariha agreed that LTE positions are hard to fill. Roll Vote: Yes (20), No (0); MC.

The jail can hold 32 inmates, we are at 23 today per Jail Administrator Gretchen Nielsen. It was reported that we are in state violation with our classifications (these have changed since the jail had originally opened) because we don't have the room to keep certain classifications of inmates separate. Before COVID, 30-40 inmates were housed outside of the county at an approximate cost of \$500,000/year. The proposed study will provide a design that will incorporate future needs without the need for additional staff. Chair T. Mackie commented that our current jail was designed with an add-on feature. Public Private Partnership Board Resolution

By and Between the County of Washburn, Wisconsin and Chibardun Telephone Cooperative, Inc. dba Mosaic Technologies

WHEREAS, the County of Washburn, a political subdivision of the State of Wisconsin, seeks to help provide access to resources and the support structure necessary for economic development within its boundaries; and

WHEREAS, Chibardun Telephone Cooperative, Inc. dba Mosaic Technologies ("Mosaic"), a Wisconsin corporation proposes to expand broadband capability to reach the unserved or underserved residences and businesses in Washburn County where such service is currently unavailable; and

WHEREAS, it is currently expected that the proposed broadband expansion would be constructed in areas within Washburn County, Wisconsin and the enhanced broadband access and availability will be utilized to position Washburn County for desirable economic growth by addressing existing service disparities and ensuring equitable access to dependable fiber services which are critical to healthcare, education, and e-commerce; and

WHEREAS, Mosaic is applying for an ReConnect 4 Grant, through the Rural Utilities Service, a Rural Development agency of the United States Department of Agriculture (USDA) to expand access to broadband services in Washburn County; and

WHEREAS, to further support its application for broadband expansion grant, the Washburn County Board of Supervisors enter into a Public Private Partnership agreement with Mosaic, to assist in this Project by:

- The County providing in-kind assistance to the project which may be in the form of waived fees and expenses for obtaining permits or permissions required from Washburn County government;
- Granting permission on and across County property to engage in activities to construct the project in compliance with all existing rules and regulations;
- Providing community education and outreach regarding the expansion of broadband access to residences and businesses within the scope of the project; and recognizing that the broadband expansion project is a priority and is consistent with internal planning documents adopted by Washburn County government.

Resolution Approving Investing ARPA Dollars for Courthouse Door Security Project

WHEREAS, in addressing courthouse security issues via both internal reviews and an external security report completed by the Federal Marshall's office, it has been recommended that door security be upgraded; and,

WHEREAS, in order to increase security and have better control access to internal office spaces a plan has been developed to install card readers and associated lock hardware on office, suite and high traffic mechanical room doors; and,

WHEREAS, this project covers 15 doors in the Courthouse and is a continuation of our long term campus security upgrade project; and,

WHEREAS, the ARPA Committee has reviewed and approved this project to be funded with Fiscal Recovery Funds for the anticipated cost of \$68,000.

THEREFORE, BE IT RESOLVED, that the Washburn County Board of Supervisors approve the investment of up to \$68,000 for the Courthouse Door Security project.
