

BASIC RULES

1. This is an alternative to incarceration and is imposed in lieu of jail. There is an obligation to avoid any drug/or alcohol use whatsoever and volunteer to be screened for drug or alcohol use if a request is made by the Coordinator or law enforcement officials.
2. Enrollee will be in the home during the pre-arranged hours. Only variation includes scheduled travel time, work, treatment appointments, appointments with PO, doctors appointments etc.
3. Any issue related to schedule, address, and phone number changes must be communicated by the enrollee to the Washburn County Justice Programs Coordinator, Kim Shafer, at 715-520-7684. Changes will be requested 24 hours in advance and Thursdays by noon for weekend changes.
4. Final determination is through the Court System

VOICE RECOGNITION MONITORING

Enrollee will receive random pre-recorded calls from the system and be required to call back into the system **within three (3) minutes**. A prerecorded voiceprint will be used to verify that the enrollee has returned the call.

All enrollees must have a private phone line (landline) with basic touch-tone service. Phone features that would block incoming long distance calls or be termed a privacy director are not allowed.



ELECTRONIC MONITORING

Enrollee will be fitted with an ankle bracelet and have a monitoring box in their home. Enrollee must have a land line.

The system will track when the Enrollee is present at the residence and when the Enrollee leaves the residence.



GPS MONITORING

Enrollee is will be fitted with an ankle bracelet to monitor their whereabouts at all times. A schedule will be predetermined for the time the individual is on monitoring.

IN-HOM ALCOHOL MONITORING

The IN-HOM alcohol monitor is a device equipped with a camera allowing for positive photo identification. Enrollee will not wear a hat, glasses, etc that may hide or alter the face from the camera. This is an alcohol specific fuel cell based device.

Enrollee does not need a landline but will need to keep the device plugged into a wall outlet consistently. This device is usually paired with another monitoring device to ensure sobriety.

FEES FOR MONITORING

The Washburn County Criminal Justice Coordination Council has set fees for monitoring. These fees are on a sliding scale dependent upon income.

Payments can be made by cash, check or money order and made out to Washburn County. All payments are given to the Coordinator or designated representative. A fee will be applied for any returned checks. If you are removed from the program/monitoring for any reason prior to your completion of monitoring, you will not be refunded.

Enrollee will need to provide a recent paystub or most recent year's income tax return for verification.

If the entire balance is paid the day of enrollment, a 10% discount will be applied.
